Prevailing Wage Rate Determinations. Applicable prevailing wage rates are those wages and fringe benefits in effect on the date the contract is awarded. All pre-determined rate increases listed at the time the contract is awarded must also be paid, beginning on the dates specified. Rates may change between the time of issuance of the determination and the award of the public works contract.

The Department of Labor and Industry, through the Bureau of Labor Law Compliance, determines prevailing wage rates for the construction industry and enforces the rates and classifications under heavy, highway and building construction projects of \$25,000 or more when public funds are involved.

Director's General Prevailing Wage Determinations

When the Overtime Notes in the Prevailing Wage Rate Determination state that the overtime rates are "inclusive of benefits," the benefit rate is increased by the same factor as the wage rate (i.e. multiplied by 1.5 for time and one-half, multiplied by 2 for double time, etc.).

PREVAILING WAGE RATE DETERMINATION

The Prevailing Wage Act requires contractors and subcontractors to pay laborers, workers and mechanics employed on PUBLIC WORKS construction projects no less than the general prevailing rate of wages (consisting of hourly cash wages plus fringe benefits) for work of a similar character in the county where the work is performed.

Prevailing Wage Rates - Conciliation and Mediation Division

Prevailing Wage Act The Prevailing Wage Act (Title 12-4-401 (Part 4)) protects wage earners from unfair practices regarding pay on state-funded highway construction projects. The Act also requires the Department of Labor and Workforce Development to conduct a survey to determine wage rates for various job classifications for state-funded highway construction projects.
